RULE BOOK

Article I. TITLE

Section 1.01 The competition shall be called Memorial Drafting Competition (hereinafter referred as competition)

Section 1.02 Moot Court Committee is the organising committee.

Article II. ELIGIBILITY

Section 2.01 Following students of Govt. New Law College are eligible for participating in competition.

- (a) Students of B.A.LL.B. 2nd, 3rd, 4th, 5th Year
- (b) Students of B.B.A.LL.B. 2nd, 3rd, 4th Year
- (c) Students of LL.B. 2nd, 3rd Year
- (d) Students of LL.M 2nd Year

Section 2.02 Team Composition-

- (a) Subject to clause (b), anyone can register individually or as a team.
- (b) Team can consist of not more than 2 persons. If anyone registers as an individual, he cannot afterward add any member to make a team. If any team is registered then no member can be substituted.

Article III. REGISTRATION

Section 3.01 Registration shall be completed by sending an e- mail on mccgnlc@gmail.com

Section 3.02 Registration shall begin from 12-12-2020 (after 11:00 am). Last date for registration is 22/12/2020 (Not after 3:00 pm).

Section 3.03 Mail should contain following details of participant/ each member of team.

- (a) Subject - '**Participation in Memorial Drafting competition**'
- (b) Name
- (c) Class
- (d) Contact number (WhatsApp)
- (e) Mail- id

Section 3.04 In case of omission to mention any detail, team will not be registered.

Section 3.05 No team/ participant should send more than 1mail for registration. Even if a subsequent mail is sent, then too first mail will be considered for registration.

Section 3.06 MCC will send a confirmation mail within 24 hours from receipt of registration mail. Moot proposition, Team Code/ Participant code (to be called team code for all purposes) and side to be represented by team/ participant will be assigned in confirmation mail.

Section 3.07 In case of non receipt of confirmation mail contact committee.

Article IV. MEMORIAL DRAFTING RULES

Section 4.01 Memorial should be prepared only from the side assigned in the confirmation mail.

Section 4.02 Memorial in no case shall exceed 25 pages (excluding Cover page and Annexure)

Section 4.03 Only following should be contained in memorial (sequentially)-

- (a) Cover page [Blue for Plaintiff/Petitioner/Applicant/ Appellant] and [Red for Defendant/Respondent]
- (b) Team Code on top right corner of cover page
- (c) Table of Content
- (d) Index of Authorities
- (e) Statement of Jurisdiction
- (f) Statements of Facts
- (g) Issues
- (h) Summary of arguments
- (i) Arguments Advanced
- (j) Prayer
- (k) Annexure

Section 4.04 Guidelines for Annexure

- (a) All reference material should be annexed in memorial under heading Annexure.
- (b) All material cited for reference shall be annexed in following order-
 - (i) Annexure: I - Statutes (only relevant provisions)
 - (ii) Annexure: II - Indian Supreme Court Judgments
 - (iii) Annexure: III - Other Judgments of Indian Courts
 - (iv) Annexure: IV - International Judgments
 - (v) Annexure: V - Books reference
 - (vi) Annexure: VI - Other relevant attachments

Section 4.05 Any reference made without annexing the relevant part will not be counted. Every authority annexed should contain footnote number(s) in which it is referred.

Section 4.06 Citation format- Bluebook 21st Edn.

Section 4.07 Specification-

- (a) Language- English
- (b) Page- Legal Page
- (c) Margins-2.54 cm. (All sides)
- (d) Font Style- Times New Roman
- (e) Font Size heading- 14 ; other than heading-12
- (f) Font Size Foot Note- 10
- (g) Line Spacing-
 - (i) Footnote- 1
 - (ii) Other than Foot note- 1.5
